** No refunds will be issued for unused or partially used dive packages. Our policy is intended to be fair to our guests, and yet prevent the loss of income to our business. Due to the location of our vessels, we must depend on advanced reservations. If a reservation is canceled within the 90 days prior to a departure we will refund the total paid less an administration fee ONLY if we manage to rebook the space AND the vessel is full. Substitution of passengers is permitted. Refund does not apply to Febrina bookings without consent of owners.
